**Position Summary:**

The motel Housekeeper is responsible for carrying out all aspects of general cleaning duties within the Motel to a high standard.

**Key Responsibilities and Objectives:**

- Maintain a high standard of cleanliness throughout the motel rooms and the motel facilities including but not limited to vacuuming, dusting, polishing, disinfecting, spot cleaning, removal of cob webs, windows and scrubbing.
- Complete duties assigned to each shift in a competent and timely manner, including but not limited to room services and check out procedures, restocking trolleys, laundry duties, cleaning duties, bed making and reconfiguration and safe and correct chemical use.
- Present a professional image and standard of behavior when engaging with members and guests.
- Conduct all cleaning operations with minimal noise or disruption to Motel guests
- Aid the Motel Manager and Motel Supervisors in providing excellent Motel facilities.
- Be proactive in reporting or addressing issues or items that need attention within the Motel.

The incumbent can expect to be allocated duties, not specifically mentioned in this document, but within the capacity, qualifications and experience normally expected from persons occupying positions at this classification.

**Key Selection Criteria:**

- Cleaning and hospitality experience within a similar environment.
- Ability to work to a high standard with minimal supervision and commitment to work as part of a team.
- Ability to manage time and follow instruction.
- Good interpersonal skills, with a friendly manner when dealing with public and other staff members.
- Willingness to work weekends and variable shifts as required.
